## FISHING BULLETIN



Captain Harry Weinblatt F/V Blue Marlin

Our 2008 season is in progress and our club members are taking advantage of it. Firstly congratulations to Capt Sean Libby and the crew of the Aurora, drawing first blood this year with a very respectable 480 lb. Thresher Shark. This monster was caught two days before the Hudson Anglers Shark Tournament and absolutely got the juices flowing. The Hudson Anglers Tournament was a success for many of the FTC boats this year. Congratulations to John Gerrity on the Moon Child on the clubs first mako of the season a 165lb speciman taken during the Hudson Tournament. Congratulations are also in order to The Lady E on their respectable 193lb. Mako as well as the Margarita Bill, Bunker Dunker and Aurora (again) on their 150 lb. Makos. A week earlier the crews of the Blue Marlin and Oceanic fished the South Jersey Shark Tournament. These two vessels were flying the FTC flag proudly, however 100lb. class Makos were in abundance and to small for the tournaments 200lb. minimum size requirements.

On the offshore scene, The Annual Woodcleft Shark Tournament went off as planned this past weekend. With the anticipation of last weeks catches the boats fanned the compass rose at the start. Although the fishing was off for most, congratulations are in order to Capt Bob and the crew of the Joint Effort, they weighed in a respectable 208 lb. Thresher Shark. Not quite big enough for the tournament money but big enough to take the FTC Calcutta. Our regular canyon commuter Wasabi and crew continue to ply the shelf waters and on his most recent trip reported a bakers dozen of Bluefin

and Yellowfin fishing a temp break in Mayes Canyon about three weeks ago. There is beautiful water that has been sliding between 500 and 1000 fathoms south of the Hudson Canyon and west towards Toms Canyon should not be to much longer before the first decent reports start coming into our local inlets.

One the inshore scene Mike Wagner aboard his Mikes Mistress has reported fluke action is in progress. With his crews perseverance they have managed good catches of fish fishing through the shorts and around structure laiden areas.

The seabass fishing still continues to produce quality action locally, however this action is off from the last two months.

Our striped bass fishery is in full swing, many FTC vessels have reported excellent catches the last two weeks fishing in and around the bunker schools which have taken up residence east of our local inlet. The fish have all been decent size with fish taken up to the mid thirty pound range. Closer to home the crew of the Four Bells has been kept busy in the evenings playing catch and release with many quality bass in the 30" plus range fishing our local back bays.

# CONSERVATION

NEW YORK, NY (June 23, 2008) - Attorney General Andrew M. Cuomo today announced a lawsuit against the federal Department of Commerce for violating federal law with its new limits on recreational catches of summer flounder along the east coast. The suit charges that their regulations will harm New York's anglers and the recreational fishing industry, without benefiting the long-term healh of these popular sportfish.

In May 2008, the NMFS adopted state-by-state limits for regulating summer flounder catches for the current season. In violation of the laws governing state-by-state regulations, the new regulations subject New York anglers to the strictest catch limits of any other state.

catch limits of any other state, including neighboring states. For example, New Yorkers can keep four fewer fish per day than New Jersey anglers.&nbp; New Yorkers are also only allowed to keep fluke over 20.5 inches -- two and a half inches longer than those that can be kept by New Jersey anglers -- barring New Yorkers from keeping most of the fish they catch. Furthermore, the NMFS based the new regulations on a one-year survey conducted almost

10 years ago; experts have severely criticized this survey as being scientifically invalid.

Finally, there is no evidence that the state-by-state regulations adopted by the NMFS properly conserves the population of fluke, which is the ultimate goal of these regulations.

The suit filed today seeks to invalidate the new federal regulations and to direct the NMFS to adopt the alternative "coast wide" approach for managing recreational east coast catches of summer flounder. The lawsuit was filed in the United State District Court for the Eastern District of New York.

The suit is being handled by Assistant Attorney General Andrew Gershon under the supervision of Special Deputy Attorney General for Environmental Protection Katherine Kennedy.


### TREASURER'S REPORT

- 5. You don't actually pay the entry fee until August after the tournament is over


